

## COVID-19 - Country Restrictions and Requirements

*Updated 9 March 2022*

It is imperative all travelers remain up-to-date and situationally aware as restrictions and requirements are subject to change with little to no notice and may be at the discretion of local authorities. Regularly monitor exemptions to entry restrictions for business or work-related travelers which may differ from that of tourists.

**When testing/vaccine requirements apply, ensure the correct type of test/vaccine is utilized and it is taken within the permitted time frame.**

### COVID-19 Pre-Travel Restrictions Checklist:

- Destination Country restrictions
  - City/Regional level restrictions
  - Confirm entry requirements with the local embassy and airline
  - Apply for your Visa early to allow for delays in processing/appointment times
  - Ensure the destination's operating status and any rules in place, including any testing requirements
- Travel Itinerary – Rules & Restrictions for:
  - Airline
  - Airport
  - Public transportation, if applicable
  - Accommodations – reconfirm reservation within 24 hours of departure and any changes to rules and regulations
- Home/Onward Country restrictions
  - Entry restrictions and requirements (testing, proof of vaccination, or proof of recovery, exemptions and quarantine)
  - City/Regional level restrictions (i.e. mask requirements)
- Confirm and collect all required documentation as needed, may include, but is not limited to the following:
  - Proof of essential travel:
    - Letter from employer (at origination and destination, when possible)
    - National Interest Exception, when applicable
  - Proper insurance coverage



- ❑ Proof of a negative COVID-19 test (required time frame and type of test varies by country)
- ❑ Traveler health forms – these vary by country and can almost always be filled out online. Countries differ on when this should be submitted, some require approval before entering.
- ❑ Proof of vaccination, when applicable – ensure the type and manufacturer of the vaccine is accepted in your arrival country

## Commonly Traveled Country Restrictions

*This list is by no means exhaustive, but rather includes some of the more commonly traveled countries. Please let us know if we can look into any travel not covered here.*

Country	Restrictions
<a href="#">Austria</a>	<p><b>Entry/Exit Restrictions:</b> Austria is operating under the <a href="#">"3-G" Rule</a>: All travelers arriving to Austria must show:</p> <ul style="list-style-type: none"> <li>● Proof of vaccination <ul style="list-style-type: none"> <li>○ Two-dose vaccinations are currently valid for 270 days after the second or any additional dose. There must be at least 14 days in between the first and second jab and 90 days between the second and third one.</li> <li>○ The Johnson &amp; Johnson vaccination is valid for 270 days, 22 days after the first dose.</li> <li>○ BioNtech/Pfizer, AstraZeneca, Covishield, Covaxin, Covovax, Johnson &amp; Johnson, Moderna, Nuvaxovid (Novavax), Sinovac, and Sinopharm are valid for ENTERING Austria.</li> <li>○ Please note: Only BioNtech/Pfizer, AstraZeneca, Johnson &amp; Johnson, Moderna and Nuvaxovid (Novavax) are currently recognized for the "3-G" rule when in Austria.</li> </ul> </li> <li>● OR Proof of past infection <ul style="list-style-type: none"> <li>○ You may enter Austria for 180 days after a SARS-CoV-2 infection.</li> <li>○ the medical document needs to show the date of recovery – for guests from the UK: an NHS email/text of a positive test is not sufficient</li> </ul> </li> <li>● OR a negative test. <ul style="list-style-type: none"> <li>○ The PCR test is valid for 72 hours. The certificate needs to be issued by an official medical authority (such as a test center or a pharmacy) and include the date and time the test was taken.</li> <li>○ LFT/antigen tests are valid for 48 hours. Do-it-yourself kits are not recognized.</li> </ul> </li> </ul> <p>Entering Austria without "3-G" Proof</p> <ul style="list-style-type: none"> <li>● <a href="#">Pre-travel clearance</a> is required when entering without "3-G" proof.</li> <li>● If you travel to Austria without proof of vaccination/recovery or a negative test, you immediately have to self-isolate. As soon as you have a negative test, you can leave quarantine.</li> </ul> <p><b>Testing Locations:</b> <a href="#">Please find information about testing here.</a> <a href="#">Information on "EU Digital COVID Certificates" issued in Austria</a> <b>Internal Restrictions</b> are in place (updated 13 December):</p> <ul style="list-style-type: none"> <li>● For almost all public indoor and some outdoor spaces (hotels, restaurants, events etc.), you will need to show proof of vaccination (Covishield, Sinopharm and Sinovac are not accepted for entering any type of accommodation, restaurants, bars, nightclubs, leisure centers, gyms, cultural institutions, on cable cars/ski lifts and for body-related services)</li> <li>● Face masks are required on public transport and in other public spaces.</li> </ul> <p><b>Current as of 9 March</b></p>
<a href="#">Belgium</a>	<p><b>Entry/Exit Restrictions:</b> Non-essential journeys to Belgium are prohibited for people who are not nationals of one of the EU+ states and whose main residence is in a third country, except countries on the <a href="#">EU white list</a>, or if they are vaccinated or traveling for essential purpose. Travelers must provide:</p>



	<ul style="list-style-type: none"> <li>• A mandatory <a href="#">passenger locator form</a> (PLF) is required for all travelers entering Belgium and staying at least 48 hours, within 48 hours prior to arrival.</li> </ul> <p><b>Entry Exemptions:</b></p> <ul style="list-style-type: none"> <li>• Fully vaccinated travelers</li> <li>• Cross-border workers that cross the border at least once a week.</li> <li>• Travelers who only transit by air and who remain exclusively in the transit zone without entering Belgian territory.</li> <li>• People with critical roles in essential sectors.</li> <li>• Non-vaccinated people, outside the EU+ and not included on the “white list”, are not allowed to travel to Belgium, unless the purpose of their travel is “essential.” Must carry an official authorization of essential travel, delivered by the diplomatic mission or the consular post of Belgium, or official documents confirming the essential nature of the trip.</li> </ul> <p><b>Testing Locations:</b> Testing locations in Belgium can be found <a href="#">here</a>.</p> <p><b>Quarantine Requirements/Exemptions:</b> A quarantine of 10 days depends on the <a href="#">region/country</a> of origin.</p> <ul style="list-style-type: none"> <li>• Arrivals from green or orange zones: with or without an EUDCC, are not subject to testing or quarantine requirements.</li> <li>• <b>All other vaccinated arrivals are not subject to testing or quarantine requirements</b></li> <li>• <b>Unvaccinated individuals must provide a negative COVID-19 PCR test result taken a maximum of 72 hours before arrival, or negative COVID-19 rapid antigen test results, taken a maximum of 24 hours before arrival.</b></li> <li>• Visitors staying in Belgium for less than 48 hours do not have to go into quarantine. If quarantine is requested, it can be lifted to fulfill an essential function or to meet the essential need of the travel if this activity cannot be postponed.</li> </ul> <p><b>Vaccine Exemptions:</b> Vaccines requiring two doses should be administered in the same country. Pfizer/BioNTech, Moderna, AstraZeneca/Oxford, Janssen, and the Covishield vaccine are currently the only accepted vaccinations for travel to Belgium. Travelers from outside the EU+ and not included on the “white list” that are fully vaccinated people (for at least 2 weeks) who possess a vaccination certificate recognized by the Belgian government are allowed to travel to Belgium.</p> <p><b>Internal Restrictions:</b> Face masks are mandatory in public places.  <b>Beginning 7 March, no longer will anyone be required to present a valid COVID Certificate when accessing bars, restaurants, and cafes, among others. In addition, the current restrictions that apply for different events will also be lifted.</b>  <b>Current as of 8 March</b></p>
<p><b><a href="#">Brazil</a></b></p>	<p><b>Entry/Exit Restrictions:</b> Foreign travelers must show proof of vaccination to enter the country.</p> <p>Passengers are allowed to freely transit as long as they do not leave the international airport area and have a ticket for onward travel.</p> <p>Passengers must provide:</p> <ul style="list-style-type: none"> <li>• Fill out a <a href="#">health declaration</a> form within 24 hours of departure</li> <li>• provide a negative COVID-19 RT-PCR or antigen test result is required. <ul style="list-style-type: none"> <li>○ RT-PCR tests must be taken a maximum of 72 hours before the first leg to Brazil.</li> <li>○ Antigen tests must be taken a maximum of 24 hours before the first leg to Brazil.</li> <li>○ The test results must be in English, Spanish, or Portuguese.</li> </ul> </li> <li>• Proof of vaccination or meet one of the exemptions below</li> </ul> <p><b>Testing Locations:</b> Testing locations at São Paulo-Guarulhos International Airport can be found <a href="#">here</a>.</p>



	<p><b>Quarantine Requirements/Exemptions:</b> Travelers exempt from proof of vaccination, upon entering Brazilian territory, must undergo quarantine for 14 days in the city of their final destination and at the address registered in the Traveler's Health Declaration. They may take a COVID-19 test on day 5 of quarantine and end quarantine with negative test results.</p> <p><b>Vaccine Exemptions:</b> Fully Vaccinated: Vaccinated travelers must have a printed or electronic proof of vaccination, showing they received all vaccine doses required at least 14 days before travel. The Brazilian government currently accepts vaccines approved by the WHO or Anvisa. Vaccines accepted by Anvisa are Comirnaty (Pfizer/Wyeth), Coronavac (Butantan), Janssen Vaccine (Janssen-Cilag), Oxford/Covishield (Fiocruz e Astrazeneca), and Sputnik.</p> <p>Entry is not permitted for unvaccinated travelers unless you meet one of the exemptions:</p> <ul style="list-style-type: none"> <li>• Travelers who cannot be vaccinated for medical reasons;</li> <li>• Humanitarian reasons, or travelers coming from countries with low vaccination coverage;</li> <li>• Travelers with a health condition that contraindicates vaccination, certified by a doctor;</li> <li>• Those not eligible for vaccination due to age according to the latest publishing on the Ministry of Health website;</li> <li>• Brazilians and foreigners residing in Brazilian territory who are not fully vaccinated;</li> <li>• Brazilians and foreigners residing in Brazil, who left the country until December 14, 2021, are exempt from presenting proof of vaccination or quarantine on return but they must have a pre-travel negative test result.</li> </ul> <p><b>Internal Restrictions:</b> Restrictions vary from city to city. The use of face masks in streets, public spaces such as parks, and on public transport including taxis is mandatory in some states. There may be additional local requirements for use of masks in other places, such as shops and gyms. Social isolation measures have been lifted to an extent in some parts of the country, but localized lockdowns continue to varying degrees. Failing to comply may result in a fine.</p> <p><b>Current as of 8 March</b></p>
<p><a href="#"><u>Canada</u></a></p>	<p><b>Entry/Exit Restrictions:</b> As of 15 January, some foreign national travelers who were previously allowed to enter Canada without being fully vaccinated will now be required to be fully vaccinated in order to enter Canada.</p> <p>As of 21 December, all Canadians returning from short trips must take a molecular pre-entry test. The test can't be taken in Canada before you leave. Those who qualify for the fully vaccinated traveler exemption can enter Canada for discretionary (non-essential) travel:</p> <ul style="list-style-type: none"> <li>• Final dose of vaccine must be completed at least 14 days prior to entry and proof of vaccination submitted to <a href="#">ArriveCan</a> and may be required to report daily during their stay. <ul style="list-style-type: none"> <li>◦ Accepted vaccines: Pfizer/BioNTech, Moderna, AstraZeneca and Johnson &amp; Johnson</li> </ul> </li> <li>• Fully vaccinated travelers will not need a post-arrival test <b>unless they have been randomly selected at the port of entry</b> to complete a COVID-19 molecular test</li> <li>• All travelers coming into Canada, regardless of vaccine status, will need a negative PCR or molecular test within 72 hours of entry (Rapid antigen tests aren't accepted) OR proof of a previous positive test result taken between 14 and 180 days.</li> </ul>



	<p>Fully vaccinated travelers who have been in any country other than Canada and the United States in the 14 days may be selected for arrival testing must quarantine in a suitable place until they receive a negative test result.</p> <p>The final determination of entry will be made by an official at the port of entry.</p> <p>All Travelers must:</p> <ul style="list-style-type: none"> <li>• Use <a href="#">ArriveCan</a> before boarding a flight to Canada to submit travel and contact information, quarantine plan, and COVID-19 self-assessment.</li> <li>• Report daily during the stay.</li> <li>• All travelers crossing the land border will be required to provide proof of a negative COVID-19 molecular test result taken in the US within 72 hours of arrival or a positive test taken 10 to 180 days prior to arrival or a negative antigen test within 24 hours of arrival.</li> <li>• Travelers by air, 5 years or older, will be randomly selected to take a COVID-19 molecular test when they arrive in Canada before exiting the airport</li> </ul> <p>Entry restrictions and requirements may vary by Province:  <a href="#">Alberta</a>, <a href="#">Saskatchewan</a>, <a href="#">British Columbia</a>, <a href="#">Manitoba</a>, <a href="#">Ontario</a>, <a href="#">Quebec</a>, <a href="#">Nova Scotia</a></p> <p><b>Entry Exemptions: Essential Business.</b> Individuals that install, inspect, repair or maintain equipment to support critical infrastructure. Exemption will be validated for each entry. Temporary workers arriving from anywhere, must prove they are listed as being exempted from travel restrictions; are traveling for a non-discretionary (essential) purpose; are not presenting signs or symptoms of COVID-19; and have a plan to quarantine for 14 days, unless exempted.</p> <p>As of November 30, 2021, all exempt essential service providers will be required to identify their vaccination status in ArriveCAN, regardless of whether or not they are allowed to enter as unvaccinated.</p> <p>Foreign nationals who have obtained an exemption to enter Canada, will be refused entry, if they do not have a valid COVID-19 molecular test result.</p> <p><b>Testing Locations:</b></p> <ul style="list-style-type: none"> <li>• At some arrival airports and at land borders- <a href="#">here</a></li> <li>• Other locations may be found- <a href="#">here</a></li> </ul> <p><b>Quarantine Requirements/Exemptions:</b> Travelers are subject to <a href="#">mandatory</a> self-quarantine for 14 days, with the exception of essential employees (medical staff or employees in the trade, transportation or critical infrastructure sectors). Border control agents determine an individual's eligibility for entry and/or exemptions. A molecular test must be taken on day 8 of the 14-day quarantine period.</p> <p><b>Vaccine Exemptions:</b></p> <p>To be considered fully vaccinated, you must:</p> <ul style="list-style-type: none"> <li>• Be eligible to enter Canada. Visit this <a href="#">website</a> to determine your eligibility.</li> <li>• Have received the full series of an accepted COVID-19 vaccine or a combination of accepted vaccines: Pfizer-BioNTech, Moderna, AstraZeneca/COVISHIELD, Janssen (Johnson &amp; Johnson) - single dose. As of 30 November: Sinopharm, Sinovac and COVAXIN will be added to the list of accepted vaccines.</li> <li>• Have received your last dose at least 14 days prior to the day you enter Canada</li> <li>• Upload your proof of vaccination in ArriveCAN</li> </ul> <p><b>Internal Restrictions:</b> Masks may be mandatory in public spaces.  <b>Current as of 8 March</b></p>
<p><a href="#">China</a></p>	<p><b>Entry/Exit Restrictions:</b> Prior to entry to China travelers must:</p> <ul style="list-style-type: none"> <li>• Apply for a visa: <ul style="list-style-type: none"> <li>○ Foreign nationals involved in essential activities may apply for visas at Chinese embassies or consulates.</li> <li>○ Holders of valid residence permits attached to work, personal matters and reunion can re-enter China.</li> </ul> </li> </ul>



- Holders of expired residence permits can apply for a new one. You should check the eligibility of your visa with a Chinese Embassy or Consulate before booking travel.
- Submit a Health Declaration Form, a certificate of [a negative COVID-19 test](#) and an IgM antibody test taken within 48 hours of departing for China (specified as a 'nucleic acid' test by Chinese authorities) and submit the results to their local Chinese Embassy/Consulate
  - Passengers who are transiting another country for a connecting flight must take both tests a second time in their last transit country within 48 hours before boarding the plane to China. Passengers must apply from the Chinese Embassies/Consulates in BOTH countries (the U.S. and the last transit country) for green health codes with the "HS" mark or certified health declaration forms with their certificates of negative results of both tests.
  - [List of countries](#) where China-bound passengers are required to show a negative COVID-19 test before boarding.
  - Updated 5 January 2022, changes to take effect for travel starting on 13 January 2022: [Notice on China-bound foreign passengers' application for health codes](#). Includes responsible diplomatic mission assignments in the U.S. depending on departure city and extensive details on testing requirements starting 7 days before departure up to a final test 48 hours before departure.
  - Travelers from the U.S. will have to present tests from specific laboratories. Consulates will publish their lists separately.
- Apply for a green health code with the "HS" mark or a certified health declaration form (after testing). Foreign passengers can apply for the QR code by logging on to the [official website](#). (Includes U.S. travelers)
- Travelers from countries designated as high-risk may only enter if they are fully vaccinated Hong Kong residents, and then must quarantine for 14 days and take 6 tests. Following quarantine, individuals must continue to self-monitor and undergo additional testing on specific days. A list of the location risk levels and quarantine and testing requirements for Hong Kong can be found [here](#).

Non-compliance can result in prison.

**Entry Exemptions:** Foreign travelers who provide essential services and holders of valid residence permits

**Quarantine Requirements/Exemptions:**

- All travelers who enter China are screened upon arrival and subject to a 7-14-day quarantine.
- Restrictions regarding domestic travel tightened slightly due to increased cases; local quarantine requirements can vary significantly between cities, and regulations can change very quickly.
- All international arrivals should be prepared to complete quarantine at a government-selected facility or hotel at their own expense, with no control over the amenities, even if they maintain a residence in China.
- Foreign visitors may also be required to install and use location tracking software on their phones in order to access public spaces and some businesses.
- Please consult local authorities on specific quarantine requirements.

**Vaccine Exemptions:** China accepts U.S. travelers inoculated with American-made vaccines (Pfizer, Moderna, and Johnson & Johnson). Passengers must get all the required shots before their trip to China. China-bound passengers are also required to provide positive IgM antibody test results as well as negative nucleic acid test results.

**Internal Restrictions:** Vary by province and city and can occur at a moment's notice, although current measures in Hong Kong have been extended to 3 February with extensions likely. Flights (both domestic and international) are very limited and experience delays or cancellations. Public transport operators in most major cities also



	<p>require passengers to share health code information before boarding mass transit. Officials also require facemasks on public transport. Local officials continue to impose travel, business, and gathering controls in multiple areas with COVID-19 cases.</p> <ul style="list-style-type: none"> <li>• As of 28 January, enhanced controls are reported in parts of Beijing, in Shanghai's Fengxian district and in parts of Hangzhou, Zhejiang province as well as Hebei province. It appears officials in Tianjin are still imposing tighter restrictions as well.</li> <li>• As of 31 January, officials report a downgrade of restrictions in Shenzhen, Guangdong province, Zhuhai, Guangdong province, and Zhengzhou, Henan province. Officials <u>report</u> that restrictions in Xi'an have been partially lifted in communities designated as lower risk.</li> </ul> <p>Current as of 8 March</p>
<p><a href="#"><u>Czech Republic</u></a></p>	<p><b>Entry/Exit Restrictions:</b> The conditions of entry and services in the Czech Republic are gradually easing:</p> <ul style="list-style-type: none"> <li>• All travelers will be required to fill out the <a href="#"><u>Passenger Locator Form</u></a> (Arrival Form).</li> <li>• Travelers must: <ul style="list-style-type: none"> <li>○ Have a valid digital EU COVID certificate (valid 14-270 days after completion of vaccination; the booster extends this period) OR</li> <li>○ Have proof of recovery from Covid-19 valid from 11-180 days after a positive test OR</li> <li>○ Arrivals from EU countries: may have a confirmation of negative PCR test or negative antigen (RAT) test before arrival <ul style="list-style-type: none"> <li>■ PCR tests are valid up to 72 hours before the trip and RAT are valid up to 24 hours</li> </ul> </li> <li>○ Arrivals from outside the EU: may have a confirmation of negative PCR test before arrival + undergo PCR test after arrival between the 5th and 7th day of stay</li> </ul> </li> <li>• The classification of countries into color categories of the so-called traffic light is still maintained. If the arriving person does not hold a COVID certificate of performed or completed vaccination (recognized by the EU) or a certificate of past disease COVID-19, he must undergo an RT-PCR test within 5 to 7 days of entry into the Czech Republic.</li> <li>• Everyone is required to wear a respirator indoors or in crowded outdoor areas</li> </ul> <p><b>Entry Exemptions:</b> UK citizens that have been fully vaccinated under the UK government's vaccination program at least 14 days prior to travel are able to enter the Czech Republic for any reason, including tourism, without needing to isolate or take a pre-departure PCR test.</p> <p><b>Testing Locations:</b> Testing appointments for antigen or RT-PCR can be found <a href="#"><u>here</u></a>.</p> <p><b>Quarantine/Testing Exemptions:</b></p> <p><b>Vaccine Exemptions:</b> Vaccination certificate is valid 14 days after the end of the vaccination period of 270 days, but may be extended by a booster. <a href="#"><u>Information on "EU Digital COVID Certificates" issued in Czech Republic</u></a></p> <p><b>Internal Restrictions:</b> Everyone is required to wear a respirator indoors or in crowded outdoor areas. Proof of vaccination or an arrival form may be required to enter business or receive services.</p> <p>Current as of 8 March</p>
<p><a href="#"><u>Finland</u></a></p>	<p><b>Entry/Exit Restrictions:</b> When you arrive in Finland, both general entry requirements under government decisions and the requirements of the <a href="#"><u>Communicable Diseases Act</u></a> and its <a href="#"><u>temporary amendments</u></a> apply to you.</p>



	<p>All arrivals are required to submit a negative PCR or antigen test taken no more than 48 hours prior to arrival.</p> <p>Entry from <a href="#">ALL</a> countries is only possible if you meet one of the following:</p> <ul style="list-style-type: none"> <li>● A certificate of a complete and valid vaccination series (either one or two doses depending on the vaccine) <b>AND</b> at least 7 days must have passed since the last vaccine dose has been received</li> <li>● A single certificate that the person has recovered from COVID-19 virus and has gotten one dose of vaccine. **Vaccine Exemptions:** Effective 14 February, those who are vaccinated are able to enter France.

The vaccines recognized by the EMA are Pfizer, Moderna, AstraZeneca, and Johnson & Johnson. Proof of vaccination is only valid provided that it attests to complete vaccinations:

- 7 days after the second shot for two-dose vaccines (Pfizer, Moderna, AstraZeneca)
- 4 weeks after the shot for single-dose vaccines (Johnson & Johnson)
- As of 1 February, in order to continue to be considered as fully vaccinated, persons aged eighteen and one month or over must have received a booster within 9 months following the injection of the last required dose.
  - Boosters must be completed within 7 days before entering France.

Beginning 15 December, people over the age of 65 will now have to get a booster shot to remain eligible for a vaccine passport needed to gain access to restaurants, museums, long-distance trains and other public places.

From 24 January 2022, the “pass vaccinal” (vaccine pass) will enter into force, replacing the “pass sanitaire” for people aged 16 and over. Only proof of vaccination can be used in order to issue a “pass vaccinal”; proof of a negative test result will no longer be accepted.

- France will accept the UK’s proof of COVID-19 recovery and vaccination record. If you are traveling with a printed PDF proof of vaccination status, it must date from 1 November or after to ensure that the certificate can be scanned successfully, if domestic certification is required.
  - Those vaccinated in England, Wales, Scotland and Northern Ireland can also choose to scan and save the NHS QR code into France’s “TousAntiCOVID” app.
- Other COVID status certification that conforms with the EU Digital COVID Certification scheme (e.g. from other EU member states) can also be used for entry into settings where there is a COVID status certification requirement in France.
- Fully vaccinated travelers who have been vaccinated outside of the EU can request a certificate of vaccine equivalence. The request for a certificate of vaccine equivalence can be made directly at the pharmacy. A booster shot may be required for travelers who originally received Sinovac/Coronavac or Sinopharm/BBIB-PVeroCells. Check the source for more details.
  - The cost of the certificate is €36. Travelers aged between 18 to 65, must provide proof of a booster dose between 5 to 7 months after their last dose to keep their COVID certificate active.
  - Must carry a hard copy of your vaccination certificate.

You can apply for a French Health Pass (Pass Sanitaire) by visiting a local French pharmacy and presenting your passport and vaccination card (with proof of FULL vaccination). Upon verification, the pharmacy will issue you a health pass. Next, download the app [TousAntiCOVID](#). You can store your health pass in this app indefinitely.

Alternatively, if you are in France or coming to France imminently and need a health pass, rapid antigen tests conducted in France (available on a walk-in basis at local pharmacies) serve as a health pass valid for 72 hours.

**Public spaces and services:** On 28 February, the mask is no longer compulsory in closed places subject to the “vaccination pass”. The wearing of the mask indoors remains in transport and closed places not subject to the vaccination pass.

  - The "expert" will need to provide the following for the employer to submit: resume and relevant diplomas, degrees and certificates, indicating education, qualifications, experience, reputation and/or expertise. Documents that are not in Hebrew or English must be translated to Hebrew and notarized.

**Quarantine Requirements/Exemptions:** All travelers arriving in Israel must go into isolation, regardless of their age including those considered vaccinated or recovered until receipt of a negative result on the PCR test performed upon entry to Israel or for 24 hours, whichever is earlier.

**Vaccine Exemptions:** Foreigners are not eligible to enter unless permission is granted from the Exception Committee. If entry is granted, the following conditions need to be met to be considered vaccinated:

- Those who have been vaccinated with Pfizer, Moderna, Johnson & Johnson, AstraZeneca, Sinovac, SinoPharm, the Serum Institute of India:
  - Received two doses at least 14 days before entry into Israel (but not more than 180 days before departing Israel); **OR**
  - Received a booster dose at least 14 days before entry into Israel.
- Those vaccinated with Janssen (J&J) vaccine:
  - Received one dose at least 14 days before entry into Israel (but not more than 180 days before departing Israel).
  - Received a booster dose at least 14 days before entry into Israel.
- Holders of a [digital recovery certificate](#), which is recognized by Israel, based on a positive result in a NAAT test (molecular test similar to PCR):
  - Those for whom at least 11 days have passed since the positive test by the day of their entry into Israel (but not more than 190 days before departing Israel).
  - Those who received at least one dose of the WHO-approved vaccines in addition to their recovery (there is no significance to the order of events)
- Beginning 1 December, Israel will recognize the Sputnik-V vaccine. However, persons who have received this vaccine will be required to take a serology test (antibody test) in Israel and get a positive result

**Internal Restrictions:** ["Happy Pass" system](#). Israelis will no longer be required to show their Green Passes, which show proof of vaccination or a recent negative COVID-19 test, at restaurants, movie theaters, gyms and hotels.

**Entry Exemptions:** Work, health reasons, absolute urgency, of study, return to your home, home or residence.

- **Exemption from pre-entry swab test, from self-isolation and the swab test at the end of self-isolation:** anyone entering Italy for a period not exceeding one hundred and twenty hours (five days) for proven necessity due to work, health or absolute emergency, with the obligation, upon expiry of said term, either to immediately leave the country or to start a 5-day period of monitoring and self-quarantine and, at the end of said period, to take a molecular or antigen swab test

**Internal Restrictions:** [Regions](#) are currently being classified with [a color system](#) and have the authority to restrict travelers from entering, regardless of entry to the country. Indicators for the color system can be found in Italian on this [chart](#). Face masks are required in public.

On 1 February, the validity period of Italy's Super/Enhanced green pass decreased from nine to six months from the date of the last vaccination. Fully vaccinated travelers with a third dose or proof of recovery from COVID-19 in the past 6 months are eligible for the Super/Enhanced Green Pass.

- Only this type of pass will allow for overnight hotel stays.
- Vaccination certificates after the third dose of vaccine must be issued a minimum of 14 days before travel.

In Italy, you must be able to demonstrate vaccination against COVID-19 with an EMA-approved vaccine. US citizens may present their CDC card issued by their vaccination site; it must display the full vaccination course completed within the previous 6 months. Alternatively, you can provide a negative molecular PCR or rapid antigen test result taken within 48 hours before entering a restaurant/museum etc. or a medical certificate issued by competent US authorities confirming recovery from COVID within the previous 6 months. Certificates are accepted in Italian, English, Spanish or French and can be digital or printed.

**Quarantine Requirements/Exemptions:** Travelers permitted to enter Malaysia during MCO will be subject to rapid COVID-19 testing upon arrival and will be required to pay for the test.

- All travelers arriving to Malaysia must provide the results of a COVID-19 (RT-PCR) test taken within 48 hours of departure, quarantine at the assigned quarantine location for **5 days (fully vaccinated with booster), 7 days (fully vaccinated travelers) or 10 days (unvaccinated or partially vaccinated travelers)**, and, as of 8 December 2021, additional testing requirements for travelers will include a self-administered RTK-Ag test on the second, fourth and sixth day after their arrival, and a professionally-administered RTK-Ag test on the third and fifth day after arriving.
- Travelers will be required to download the MySejahtera application and will be issued a wristband for identification and monitoring by the authorities during their self-quarantine period.
- From 13 January 2022, if you are fully vaccinated and have recently been infected with COVID-19 (11-60 days before departure), you may be exempted from mandatory quarantine. A printed or digital copy of the laboratory test results will be required as evidence of infection. A COVID-19 test 2 days before departure is still required.
- If you are arriving from a high-risk country with high COVID-19 Omicron variant cases reported you will be required to wear a digital tracker throughout your quarantine. In addition, you must undertake a daily lateral flow/RTK-Ag self-test during quarantine.
- If you were hospitalized due to COVID-19 within 11-60 days before departure, you are also required to submit a fit to travel letter from the hospital.
- Business travelers approved to enter Malaysia for a period of 14 days or less will not be required to quarantine upon arrival. Additional details on the application and approval process are available from the [Malaysian Investment Development Authority](#).
- Travelers must make a formal application for home quarantine by sending an email to the MOH Home Surveillance Order (HSO) team at hso@moh.gov.my at least 7-10 days prior to travel to request home quarantine, including the following documents.
  - Travel itinerary/tickets
  - U.S. passport
  - Malaysian visa/pass
  - Vaccine card
  - Residential address in Malaysia (where the traveler will quarantine)
  - PCR test results (send as a follow up email within three days of scheduled travel)
  - Home quarantine application form (available on MOH Facebook page)
- Travelers must print the home quarantine pre-approval notice and present it upon arrival to Malaysia.

- Travelers are allowed to transit through Korea (Rep.) for less than 24 hours without being subject to quarantine requirements.
  - All transit passengers will receive a temperature check on arrival in Korea. Symptomatic individuals will be subject to a COVID-19 test and hospitalization if found positive.

Due to COVID-19, only nationals of 49 countries/regions where [visa-free entry](#) into Korea is available and Priority Entry (Business) Persons from 63 visa-free entry suspended countries are able to apply for K-ETA from 01 September 2021.

- Visa-free foreign visitors need K-ETA approval in order to obtain the boarding pass and to enter the Republic of Korea. K-ETA is valid for multiple trips over a period of 2 years and the application fee is 10,000 KRW/person.
- K-ETA does not constitute an exemption from quarantine.

#### **Entry Exemptions:**

- Some U.S. citizens traveling to South Korea for diplomatic, business, humanitarian, or academic reasons may be exempt from self-quarantine requirements but require a pre-approved waiver from your local Korean Embassy or Consulate prior to traveling.

**Quarantine Requirements/Exemptions:** As of 3 December, all permitted inbound international travelers must quarantine for 7 days, regardless of vaccination status. If you have been fully vaccinated against COVID-19, you can apply for a ‘quarantine exemption’ which allows you to bypass quarantine when entering South Korea. The process of applying for a quarantine exemption varies depending on where you were vaccinated and the purpose of your travel.

- **\*Of Note\*** Most quarantine exemptions are currently suspended through early February to control the spread of the omicron variant, regardless of your nationality or vaccination status. If you arrive in South Korea without a valid quarantine exemption you will need to quarantine for 7 days.
- Even if you have a quarantine exemption, you will need to submit a negative PCR test taken within 48 hours of your departure (with some exceptions, see ‘Testing



	<p>on arrival' above). You will be taken to an airport testing center for your PCR test on arrival and will not be able to leave until the result has been received. **Quarantine Requirements/Exemptions:** Beginning January 1, 2022, travelers who are fully vaccinated with negative COVID-19 RT-PCR test results taken up to 72 hours before arrival must self-quarantine at home or their places of accommodation for three days upon entry. Two RT-PCR tests will be conducted on the first and third day of entry. If negative, entrants are still required to monitor their health for the next 11 days. Detailed instructions, including information for entrants who have not been fully vaccinated, are available on [the Vietnamese government's website \(Infographic is in Vietnamese\)](#).

Entrants who have not received full vaccinations must quarantine in either a designated hotel or a preapproved residence for 7 days. You will need to take a PCR test on days 3 and 7 and self-monitor up to day 14. You will be responsible for paying any hotel charges and for coronavirus testing costs. The 14-day quarantine period also applies to confirmed COVID-19 patients in Vietnam and any individual considered high-risk (e.g. those with recent contact with confirmed COVID-19 cases or with recent travel history to outbreak areas identified by the Vietnamese government).

- Please also note that the Vietnamese government may extend quarantine periods or impose post-quarantine movement restrictions if deemed necessary to minimize the spread of an outbreak.
- If you test positive, you will be treated in a Vietnamese hospital. Following discharge, you will be expected to undertake a 14-day period of self-isolation during which you should not leave home unless urgent. However, the Ministry of Health has ordered localities to continue quarantining all entrants who have completed 14-day mandatory quarantine, applicable from 4 May at both State and civilian quarantine sites for an as yet undetermined length of time.
- Testing and quarantine expenses are to be paid by the traveler. Once you have completed quarantine and self-isolation you should receive a document specifying this. You should keep this, as you may need to present it to customs/airport officials when you leave.

**Vaccine Exemptions:** Reduced quarantine periods may be offered to those fully vaccinated with a negative COVID-19 test. Vietnam is working with the United States, European Union, ASEAN countries, China, Japan, South Korea and other countries around the world for mutual recognition of a [Vaccine Passport](#) to facilitate resumption of travel. The vaccine "Green Pass" - issued by a medical facility in Vietnam as both a digital and paper copy of proof of vaccination - will allow the holder to enter certain venues or areas. Vietnam recognizes proof of vaccination from [72 countries](#).

**Internal Restrictions:** Beginning late September 2021, cities and provinces across Vietnam have gradually resumed operations of public services and lifted curfew requirements. Interprovincial transportation remains heavily restrained. Travelers should continue to closely monitor guidance from local authorities and seek assistance from their landlords, accommodation providers, employers, or sponsoring organizations in Vietnam as needed.

Vietnam uses community testing as a means to provide assurance that COVID-19 is not being transmitted undetected. Should you be asked to undertake testing, you should comply. Failure to comply can be an offense with significant punishments.
